“Negotiating Brexit – the legal landscape”

Richard Gordon QC is widely recognised as one of the UK's leading lawyers and he acts in international jurisdictions at the highest level as well as in the UK. Richard holds and has held a number of visiting senior academic appointments and has authored several works on public and constitutional law, civil liberties and EU law. Richard is a trustee of a newly established Foundation for the promotion of the rule of law in Africa, he is a Member of the Advisory Board of the Constitution Society and he has recently been appointed as a Special Legal Adviser to the Public Administration Select Committee of the House of Commons.



”Brexit – practical implications for business and individuals”

Fergus Randolph QC is at the forefront of EU law at the English bar. He regularly appears before the Court of Justice of the European Union (CJEU), General Court and UK courts. Prior to practising at the London bar, Fergus spent 15 years in Brussels including time at the European Commission and his practice has taken him to international jurisdictions such as Hong Kong, the Falkland Islands and the South Georgia Supreme Court. He is also the Chairman of the Bar Council's Law Reform Committee, Committee member of the Bar European Group and Former Leader of the European Circuit of the Bar Council. Fergus lectures frequently on all aspects of EU law and UK litigation.
